

DUBOIS COUNTY COUNCIL

DECEMBER 29, 2008

The Dubois County Council conducted its monthly meeting on December 29, 2008, at 4:30 pm, in the Council Chambers of the Courthouse Annex. Present at the meeting were Board members Gregory A. Kendall, Jerry R. Hunefeld, Leon J. Fleck, Donna L. Schroeder, Mark A. Brescher, Melvin H. Menke and Auditor Janet L. Sendelweck. President Kendall asked if there were any additions or corrections to the minutes of the last meeting. On a motion by Leon J. Fleck and seconded by Melvin H. Menke, the minutes were approved as written. The motion carried unanimously.

RE: SHERIFF – 2009 SALARY CONTRACT

Sheriff Terry Tanner appeared to request approval of his 2009 salary contract. The salary of \$75,388.00 is based on county population under 40,000 and 60% of the Prosecutor's salary. On a motion by Mel Menke and seconded by Leon Fleck, the contract was approved.

RE: SECURITY CENTER – TRANSFER OF FUNDS

Sheriff Terry Tanner appeared to request the following transfer of funds: from Cooks 2 to PT Cooks in Personal Services in the General Fund in the amount of \$3334.40 and from Jailers to PT/FT Cooks and Maintenance in Personal Services in the General Fund in the amount of \$12,197.36.
