

**ORDINANCE NO. 2019-01**

**ORDINANCE MODIFYING LOCAL INCOME TAX RATES  
IN DUBOIS COUNTY, INDIANA**

WHEREAS, pursuant to IC 6-3.6-3-1, the County Council (“Council”) of Dubois County, Indiana (the “County”), acts as the “adopting body” for the purposes of adopting a tax rate for correctional and rehabilitation facilities under I.C. 6-3.6-6-2.7;

**BE IT ORDAINED** by the Council that a need now exists to modify the local income tax rates imposed in the following way:

Certified Shares (IC 6-3.6-6)	0.6000%	0.6000%
Public Safety (IC 6-3.6-6)	0.0000%	0.0000%
Economic Development (IC 6-3.6-6)	0.4000%	0.4000%
Property Tax Relief Rate (IC 6-3.6-5)	0.0000%	0.0000%
Correctional or Rehabilitation Facilities (IC 6-3.6-6-2.7)	0.0000%	0.2000%
<b>TOTAL EXPENDITURE RATE</b>	<b>1.0000%</b>	<b>1.2000%</b>

The revenues generated by the tax rate for correctional and rehabilitation facilities identified above shall be directed to the correctional facilities and rehabilitation facilities fund, which is hereby created pursuant to IC 6-3.6-6-2.7.

The tax rate for correctional and rehabilitation facilities proposed above will become effective on October 1, 2019 and will remain in effect until modified by ordinance of the Council. The rate imposed under IC 6-3.6-6-2.7, as amended from time to time, may not be in effect for more than any statutorily limited time period or until a date upon which all debt obligations and/or costs or expenses associated with such debt obligations that are payable from revenues generated by the tax rate for correctional and rehabilitation facilities identified above have been paid and satisfied in full, whichever is sooner.

**BE IT FURTHER ORDAINED** that a public hearing was held on the proposed local income tax rate modifications on June 24, 2019. Proper notice of the public hearing was provided pursuant to IC 5-3-1.

This Ordinance shall be in full force and effect from and after its passage.
